Parish Council

At the July meeting, the Council met PC Steve Lynch, Harwell's Beat Officer, at the July meeting. He will be the area Beat Officer for the next 2½ years, and attended the meeting with PCSO Tim Dean (support Officer). Several issues were discussed, including speeding and the possibility of getting a radar speed display, and anti-social behaviour. PC Lynch asked that anyone with concerns contact him on the non-emergency number 08458 505 505.

Mr Lilly reported that he had written to OCC on behalf of the Council protesting at cuts in funding which could jeopardise bus services through the village. UKAEA's subsidy for routes 32 & 33 will remain, but new EC regulations may mean bus companies have to provide more drivers to cover rest periods. There was to be a further meeting.

At the June meeting, membership of the Council's two committees was agreed:

The Lands & Recreation Committee: John Fisher, Rod Thomas, Gary Taylor, Martin Ricketts, and Don Hayter.

Environment & Planning Committee: Mrs. Dee Boughton-Waite, Dr Keith Beswick, Stuart Lilly, David Marsh and Frank Treml.

Invited to express particular areas of interest, Stuart Lilly mentioned transport & bus routes, Gary Taylor – sports and recreation, and Martin Ricketts – environmental matters. So if you have a particular concern in one of these areas you may wish to contact them first. David Marsh is still the Council's Webmaster.

It was reported at the June meeting that there were two vacancies for Community Governors at Harwell School; anyone interested should contact the School Clerk.

Affordable Housing: At the June meeting the Parish Council met representatives of Sovereign Housing who reported that they had been unable to contact the owner. They would attempt to make contact though a third party. But at the July meeting it was reported that the owner was unwilling to accept the valuation put on the land as a site for affordable housing. The value is lower than the open market value but the site would not get permission for housing for open sale.

Lands & Recreation: It was reported at the May meeting that work was nearly finished on refurbishing the showers in the Pavilion. The new Council had decided to add re-tiling and repainting to the shower and plumbing replacement. Mr Taylor volunteered to do this with the groundsmen to keep the costs down.

Between the June and July Council meetings, the Lands Committee met representatives of the Football Club to discuss fees and arrangements. The Council had previously agreed fees were too low considering the costs of electricity etc. New fees were approved at the July meeting, after a vote because one Councillor thought the increase too large to be made in one step.

The Council also met the East Hendred Boys FC, which has asked to play some games at Harwell next season and also use the Rec. for training, for its Under-11 and Under-13 teams. Games are played on Sunday morning, and training is on Friday for the Under-11s and Tuesday for the Under-13s. The Council asked that "Harwell" should be in the team name and **Harwell boys should be eligible for the teams**. If you have a boy who wants to be considered, please contact the Harwell Football Club or the Parish Council Clerk or a Councillor for further details. Fees were agreed for the Boys teams.

It was reported at the June meeting that there had been dog fouling in the allotments. After discussion it was decided to ask allotment holders if they had had any problems recently. There is 1 allotment available as soon as anyone wants it – contact the Clerk.

District and County Councillors raised several topics in their reports. At the June meeting Colin Lamont, our County Councillor, reported that Thames Water had put its reservoir plans on hold until 2010, partly because new planning regulations may affect the proposal. In July, Reg Waite reported from the District Council that Concessionary bus fares will only be valid for local routes at off-peak times. On recycling, there had been some opposition to the £29 annual fee for a brown bin, for compost and cardboard. Parishioners are reminded that the Vale Council will still deliver free a green bin for recycling glass, clear plastic bottles and paper – call then on 01235 520202. Mrs Turner, our other District Councillor, mentioned a section 59 ruling that covers anti-social behaviour with vehicles – loud music played in parked cars is covered by this. Repeat offences could result in seizure of the vehicle by police.

There is no Council meeting in August, so the next meeting is on Tuesday 11th September. Items for the agenda should be with the Clerk, Mrs. Stephanie Taylor one week before this. A bit more on the Bargain Stone

As mentioned previously, this is Coral Rag, probably from Abingdon Abbey. If you look from the road you can see it has been worked; maybe it was thought not good enough for barn footings, for example adjacent to Grove Road, where similar stones are to be seen:



The Abbot and monks signed a deed of surrender to the Crown on February 9^{th} 1538, after being assured of decent pensions. John Wellsbourne, the King's man in charge of winding up Abbey affairs – It's estimated it was the 6^{th} wealthiest in England – found the Abbey had been stripped of all its furnishings – the community had made careful preparations for the surrender!

Within weeks the Church was dismantled and all the good quality building stone barged down the Thames. So one can assume the pieces in Harwell came soon after this date. If you look carefully at the stone you can see imprints of fossils. There are better examples however in the wall of Cherry Barn, near the entrance, with remains of the coral as well as the imprints:



At the AGM on 28th June the retiring Treasurer Trevor Packer reported that the year to March had see a modest increase in hire fees but a decline in income from the shows put on in the Hall. However, a number of donations had enabled several improvements over the year. Harwell Feast gave £500 towards the cost of the new fridge and Didcot Rotary Club gave £600 for kitchen redecoration. And a total of £6771 was spent on the new tables and chairs, the latter replacing those that had seen many years of service. Donations from Harwell W.I. of £68 and from the Out and About Club of £425, plus the £500 raised by the Safari Supper and £1500 from last year's pantomime enabled the Hall to get a Lottery grant for the remainder of the amount.

There were also two generous donations from Busy Bees Music Group totaling £250. The Hall Committee thanks all those who contributed in various ways to enable these Hall improvements.

The Chairman Colin Lamont proposed a vote of thanks to the Treasurer Trevor Packer who was standing down, which was endorsed by those present, for all his work for the Hall over the years. The Committee is grateful to Ron Haley for kindly volunteering to take over as Treasurer. The next meeting of the Hall Committee will be held on Thursday 13th September at 7.30 pm.

Update on Harwell Church Tower

Work started on the tower and other repairs at the end of June and hopefully will be finished in September. The scaffolding is up, but unfortunately the weather and other factors have delayed further progress so far. A lightning protection system for the church will be installed as part of the programme of work.

Fundraising so far now stands at just over £52,000 towards the target of £60,000. The cancellation of the Harwell Feast due to bad weather removed one fundraising opportunity, but grants and further donations (including £10,000 from the Oxfordshire Historic Churches Trust and £1,000 from UKAEA) have boosted our total.

The last fundraising event in the present series - the *Journey through Opera* evening on Saturday 7th July - was a great success and raised £2,154, thanks to the organizing efforts of Roz Shipp and her team and the four professional performers who gave their services free. Letters went out in July to those who had kindly offered pledges earlier this year, so that these could be 'called in'. From our MP – Mr Ed Vaizey - We now have a new prime minister - Gordon Brown. Brown's first announcement to the House of Commons was a number of proposals to change the constitution. I was in the Chamber for the statement, and the place was packed out. It is an exciting time in politics. Changes to our constitution don't necessarily get everyone's juices going, and they don't help pay the mortgage, something which is becoming increasingly difficult as interest rates rise. But they are important in a country where so much power is vested in the prime minister.

I support a lot of what Brown proposed. I like the idea of Parliament having a say in major public appointments. I agree that parliament should vote on whether we send our troops to war. I also think the PM should give up the power to appoint bishops and judges.

But I also think Brown should go further. I would like to see fixed-term parliaments, with a fixed date for the general election, so that we can remove the uncertainty that currently prevails. I also think we need a fully-elected House of Lords. And, with a devolved Scotland, I think Scottish MPs should lose the power to vote on English domestic issues like health and education.

Like many of you, I was caught in the floods that hit Oxfordshire. I had to abandon my car in Longcot and my home was only saved from flooding by a quick-thinking neighbour who dug a trench to drain the area.

I saw Hanney at its worst on Friday, looking much better on Sunday. When I got to Marcham on Sunday, most of the water had drained away, but I know a few houses were badly hit. Lyford was devastated. The Ladygrove in Didcot suffered terrible problems, mainly because of the poor drainage, which I am taking up urgently with Thames Water. Certain parts of Grove were badly hit, particularly Kingfishers, Vale Avenue and the houses by the Barley Mow. Steventon was also hit badly. I never made it to Stanford, or the other villages near Faringdon.

It is perhaps too soon to draw conclusions, but here are three thoughts. Although the rain and the consequent flooding is the worst we have seen for fifty years, we cannot assume it won't happen again for fifty years. Events like this are likely to become more frequent. Secondly, increased housing development must be a factor. It prevents water draining away, and many of the drainage systems themselves are very poor quality. This must cause real doubts about whether developments east of Swindon, in Grove and Didcot, not to mention the reservoir, can go ahead. Thirdly, and related, the local councils and the Environment Agency must sit down and analyse the worst affected areas and ask themselves what we can do to defend ours elves in the future, and whether, in that context, these developments should be allowed. I am pleased the Government has said they will reimburse councils for the flood damage and I will be supporting the councils in their dealings with Government.
